**Deadline for Completed Application:** August 10, 2018 (date is subject to change based on enrollment capacity).

**Notification Date:** Notifications for Rolling Admission will begin at the end of November, 2017. We aim to notify applicants on a rolling basis and roughly 30 days after a completed application is submitted. An application is considered complete only after a prospective student has completed the entrance exam, attended an on-campus family meeting, and submitted all transcripts and recommendations.

**Commitment Date:** During Rolling Admission, a student has five days from the acceptance letter issue date to commit to the contract with BASIS International School Shenzhen. We will require a shorter time frame for your commitment as we get closer to the start of the school year, as a grade nears capacity.

**Contract Binding Date:** The contract will come into force on the date the Admissions Letter is issued.
